Mrs. Freitag stated "I will be voting no on the bus purchase. I am not opposed to buying a new bus but I just think it is too soon to do so. By law, school buses can be used for 15 years. Of the two buses currently owned, one will be expiring in 2020 and one in 2021. This vote will support the purchase of a 2020 bus sometime in 2019. I have recently learned from the Dept. of Ed. that the 15 years starts with the date of the manufacture of the bus rather than the first date of use. Therefore there will be a period of time when we have 3 buses. My concern with this is that we currently have only two drivers. Therefore one bus will not regularly be used. I did ask if the new bus was intended to do a route but was told that it will not do a regular route. I do understand that 3 buses are needed to go to football games. However there is not a third driver and there is only a handful of away games each year. The idea that we have the money now is true, but this assumes that we will not have the funds in the following year. From what I hear from those at NJSBA, the funding should remain as is for the foreseeable future. I still think that this is a premature purchase.
