The Work Meeting of the Elmwood Park Board of Education was held on Tuesday, March 23, 2021 and began at 6:00 p.m. The meeting was held in the High School/Middle School Student Cafeteria. Present were: Mrs. Dorin Aspras, Mr. Keith Cannizzo, Mr. Douglas DeMatteo, Mrs. Gerardi, Mr. George Luke, Mrs. Elizabeth Mierzejewski, Ms. Carrie Paretti, and Ms. Karen Pena. Mr. Daniel Zoltek arrived at 6:04 p.m.. Also present were, Mr. Anthony Iachetti, Superintendent of Schools, Ms. Jillian Torrento, Assistant Superintendent Mr. John DiPaola, Business Administrator/Board Secretary, Mr. Mark Wenczel, Board Attorney and and Mrs. Darla Palmesino for the taking of minutes and members of the public.

Roll call was taken. The Statement of Compliance, is hereby incorporated: In accordance with the requirements of Chapter 231 of the Public Laws of 1975, known as the “Open Public Meetings Act,” this is to confirm that we are in compliance with the Sunshine Law and all appropriate postings and notices have been made. The following information is Board of Education Policy: “1) Any individual addressing the board of education is to state his/her name and address and sign the register at the podium. 2) No verbal accusation against any employee or member of the board of education shall be permitted. Such accusations may be presented in writing and will be given full consideration by the board of education. 3) No action will be taken by the board of education at the same meeting on requests from the public, which may necessitate either a new policy or a change in existing policy.”

Mr. Luke reviewed the agenda with the board.

At 6:09 p.m. the meeting was opened for board comments.

Mr. Luke discussed with the board that earlier in the week, he along with Mr. Iachetti and the chair of Use of Facilities Committee Mr. DeMatteo met with the Boro administrators to discuss the town’s plans for redoing Borough Field which would call for eliminating the softball fields and a soccer field in order to build a town center. As part of these plans the town would like to enter into a shared service agreement with the board which would include turfing the high school soccer and softball fields, which the town would then use to help offset the loss of the fields at Borough Field.

Mrs. Gerardi expressed concerns of losing use of our current fields in particular for the track program which would have no place for discus, shot put, etc if the field was turfed. She also

asked what would happen to Bomers. She later mentioned there are drainage issues with those fields.

Ms. Paretti expressed concerns that the school would lose use of the fields if the board had to share their use with the town. She also stated it is difficult to make a decision without further information regarding costs.

Mrs. Aspras questioned if there were problems with the tennis courts. Mr. Iachetti responded that yes there are cracks in the courts and the town has informed him the contractor will put in expansion joints which they say will alleviate the problem.

Mr. Cannizzo said he is all for working together with the town but within reason and the site work alone for those fields would be huge.

Concerns about insurance and access to the fields were also expressed. There were no members of the board that voiced support for the project and as such Mr. Iachetti said he would call the borough administrator and indicate that the board is not interested in pursuing this matter any further.

Mr. Luke then discussed the possibility of conducting a re-registration of the students this summer. He stated that Mr. Wartel would need help with the re-registration. Mr. Iachetti said they would conduct the re-registration in the summer for grades 6-9 and would move forward with this.

Mr. Cannizzo discussed the possibility of recognizing Taste of Italia and Franceso's for all they do in the community. Mr. Iachetti said something will be done before the last meeting.

At 6:29 p.m. the meeting was opened to the public.
