FINAL SUMMARY MINUTES – REORGANIZATION MEETING ELMWOOD PARK BOARD OF EDUCATION JANUARY 8, 2014

The Annual Reorganization Meeting of the Elmwood Park Board of Education was held on Wednesday, January 8, 2014, in the Memorial High School Auditorium at 6:30 p.m.

Present were: Keith Cannizzo, Douglas DeMatteo, Jeanne Freitag, Kathleen Policano, Arlene Rudmann, Peter Scolaro, Stephen Zaccone. Outgoing board trustee, Jennifer Pellegrine was absent from the meeting. Newly elected Daniel Golabek was also present. Also present were Dr. Richard Tomko, Ph., D., Superintendent of Schools, Wayne Demikoff, Interim Board Secretary/Business administrator, State Monitor, Thomas Egan, Mayor Richard Mola, for the swearing in ceremonies, Patricia Otten, Confidential Executive Secretary, for the taking of minutes, Alfred Annunziata, New Jersey School Boards Association Representative, for annual review of Board Trustee Code of Ethics, members of the administration, and members of the public.
