Also present were Mr. Anthony Grieco, Acting Superintendent of Schools, Mr. Angelo DeSimone, State Monitor, Mr. Wayne Demikoff, Interim Board Secretary/Business Administrator, and Mrs. Darla Palmesino, Confidential Executive Secretary, for the taking of minutes, and members of the public.

Roll call was taken. The State Monitor, Angelo DeSimone gave his quarterly report. He spoke about the district moving in the right direction and the recommendations made by the auditors are being addressed. He is satisfied with next year's budget.

Mr. Jeffrey Bliss gave his presentation for surplus estimate.

Mr. D'Amico, a member of the community, questioned the amount of the surplus.

Mr. Grieco gave the Budget presentation.

Mr. Jeff Morris from Boswell Engineering gave a presentation regarding the field project.

Mrs. Wechtler attended the math carnival at 16th Avenue. She asked Mr. Grieco to see about getting a new flag at Gilbert Avenue School.

Mrs. Policano thanked all the teachers for their hard work. She agreed that the district needs to implement electives. She was proud of the students who made the Dean's List, the Co-op students and our Students-of-the-Month. She was very impressed with the presentation by the student congress representative. EPEA is doing a wonderful job helping the community and suggested if something could be done for Nepal.

Mr. Golabek thanked Mr. DeSimone for his quarterly report. Mr. Golabek spoke about the past state monitor and superintendent not releasing information regarding the plans for the fields. He also feels the need to bring back electives and feels there is money for that. He thanked Mrs. Cascetta for organizing the math carnival at 16th Avenue. He thanked the members of the community who donated to the district.

Mr. DeMatteo attended the play, Legally Blonde and commended Mrs. Matsko, the students and all the parent volunteers for their hard work.
