- He saw 11 students at hospital who had high CO levels from EMS tests
- Safe levels were indicated through blood tests done at the hospital (most accurate test) the 11 students were released
- He then answered parents' questions about CO levels

Bergen County EMS - Mr. McNally & Mr. Rose

- RAD57 devices were used to screen students (non-evasive test Blood test are more accurate)
- Multiple EMS units were at the scene
- Mr. McNally was present day of evacuation
- Students with higher levels received oxygen
- Students were calm and taken care of at fire house
- Parents of students with higher levels were notified and advised to take them to hospital

Mr. Thomas Bishoff - Bergen County Supervisor - HAZMAT Unit

- Assisted with air monitoring at school
- Installed gas meter to test for CO levels, etc. in the school
- Conducted several Air Quality tests
- All air quality tests were negative at Gantner School and the firehouse
